AN ACT TO APPROPRIATE FOUR BILLION, TWO HUNDRED AND SIXTEEN MILLION, NINE HUNDRED AND TWENTY ONE THOUSAND AND SIX HUNDRED AND FIFTY SIX DOLLARS TO THE SERVICE OF THE YEAR ENDING 31ST DECEMBER 2016.

ENACTED by the National Parliament of Solomon Islands.

Short title and commencement

1. This Act may be cited as the 2016Appropriation Act 2015.

Authorisation of \$4,216,921,656

2. The issue from the Consolidated Fund is hereby authorised of a sum of four billion, two hundred and sixteen million, nine hundred and twenty one thousand and six hundred and fifty six dollars, to be applied to the service of the year ending 31st December 2016.

Appropriation

3. The sum specified in section 2 shall be appropriated for the supply of the heads specified, and in the amounts respectively specified in relation thereto, in the First Schedule.

Short Term Discount Securities

- **4.** (1) The Government may, at any time or times not later than 31st December 2016, borrow by way of short-term discount securities, issued within Solomon Islands, any sum not exceeding in the whole one hundred million dollars on such terms and conditions as the Minister of Finance may deem expedient.
 - (2) Proceeds from any borrowing under subsection (1) are only to be used in accordance with section 71 of the *Public Financial Management Act 2013*.

Government borrowing

- 5. (1) The Government may, in addition to its borrowings under section 4, borrow or enter into agreements to borrow on such terms and conditions as it may determine appropriate, amounts up to such sum of money for such purposes and from such sources as are respectively specified in the first, second and third columns of the Second Schedule.
 - (2) No amounts may be borrowed under subsection (1) except in accordance with an agreement under that subsection entered into on or before 31st December 2016.
 - (3) The Government shall not borrow any sum or sums in excess of the figure shown in the first column of the Second Schedule, except in accordance with *Part 8* of the *Public Financial Management Act 2013*.
 - (4) Government borrowing shall have the meaning provided in section 63 of the *Public Financial Management Act 2013*.
 - (5) The Minister shall report to Parliament in accordance with section 66(5) of the *Public Financial Management Act 2013* following such borrowing under subsection (1).

Debt Servicing Account 6. The Minister shall set aside, in accordance with section 69(2) of the *Public Financial Management Act 2013*, zero (0) per cent of the

Government's domestically sourced revenue earned in 2015 in the Government's Debt Servicing Account.

7. The total sums authorised by advance warrants issued by the Minister in exercise of his powers under section 60 of the *Public Financial Management Act 2013* for the financial year 2016 shall not at any one time exceed one hundred and fifty million dollars.

Advance warrants

8. The total sums authorised by contingencies warrants issued by the Minister under section 58 of the *Public Financial Management Act* 2013 for the financial year ending 31st December 2016 shall not exceed seventy five million for recurrent and development heads of expenditure.

NOTE: In addition to this Appropriation Bill a further \$84,230,915 is forecast to be expended through statutory power, including the \$73,122,871 to be expended on National Debt Repayments. These Statutory Appropriations are explained in the Budget Strategy and Outlook (Budget Paper 1) and the Recurrent Estimates Document (Budget Paper 2) and are appropriated by existing legislation and/or the Constitution.

OBJECTS AND REASONS

The object of this Bill is to authorise expenditure of four billion, two hundred and sixteen million, nine hundred and twenty one thousand and six hundred and fifty six dollars for the services of the Government in respect of the year 2016.

There will be no net domestic borrowing in 2016, unless Short-Term Discount Securities are issued in accordance with section 71(4) of the *Public Financial Management Act 2013* to deal with exceptional circumstances like a major economic shock or natural disaster.

This Bill sets an annual limit on new Government borrowing, as defined in section 63 of the *Public Financial Management Act 2013*. The Bill authorises new Government borrowing, up to the specified annual limit amount, for rehabilitation and development purposes.

Provisions relating to the issue by the Ministry of Finance and Treasury of Advance Warrants and Contingencies Warrants during 2016 are also included.

The Bill should be read in conjunction with the Budget Papers provided to Parliament, including Budget Paper 1: Fiscal and Economic Outlook.

The Bill provides authority for a General Warrant to be issued by the Minister for Finance and Treasury up to four billion, two hundred and sixteen million, nine hundred and twenty one thousand and six hundred and fifty six dollars to the Permanent Secretary of Finance and Treasury. This further allows the issue of Accounting Warrants by the Permanent Secretary in accordance with Sections 56 and 57 of the *Public Financial Management Act 2013*. The accounting warrants to be issued are outlined in Budget Paper 2: Recurrent Budget Estimates and Budget Paper 3: Development Budget Estimates.
