AN ACT TO APPROPRIATE AN ADDITIONAL ONE HUNDRED AND NINETY FIVE MILLION, SEVEN HUNDRED AND FORTY THOUSAND AND ONE HUNDRED AND THIRTY ONE DOLLARS, TO THE SERVICE OF THE YEAR ENDING 31ST DECEMBER 2015.

ENACTED by the National Parliament of Solomon Islands.

2015 SUPPLEMENTARY APPROPRIATION ACT 2015

Short title and commencement

1. This Act may be cited as the 2015 Supplementary Appropriation Act 2015 and commences on the date ("commencement date") of assent.

Authorisation and appropriation of \$195,740,131

- 2. (1) The issue from the Consolidated Fund is hereby authorised of a sum of one hundred and ninety five million, seven hundred and forty thousand and one hundred and thirty one dollars.
 - (2) The sum specified in subsection (1) shall be deemed to have been appropriated as from the commencement date for the supply of the heads and in the amounts respectively specified for such heads, as set out in the Schedule.

Offset Savings Variations in Appropriations \$12,346,138 3. The appropriations specified in the 2015 Appropriation Act 2015 are hereby reduced by twelve million, three hundred and forty six thousand, one hundred and thirty eight dollars as set out in the Schedule.
