

Short title. 1. This Act may be cited as the 1984 supplementary Appropriation (No 3) Act 1985.

Authorisation of issue from the Consolidated Fund of \$200,000 for the service of 1984.

2. This issue from the Consolidated Fund is hereby authorised of a sum of two hundred thousand dollars to be applied to the service of the year ending 31st December 1984.

Appropriation.

3. The sum specified in the preceding section shall be appropriated for the supply of the head specified, and in the amount specified, in the Scheudle.
