

AN ACT to appropriate ten million two hundred and seventy thousand nine hundred and sixty five dollars to the service of the year ending 31st December 1987.

ENACTED by the National Parliament of Solomon Islands.

Short title.

This Act may be cited as the 1987 Supplementary Appropriation Act 1987.

Authorisation of Issue from the Consolidated Fund of \$10,270,965 to service of 1987.

The issue from the Consolidated Fund is hereby authorised of a sum of ten million two hundred and seventy thousand nine hundred and sixty five dollars to be applied to the service of the year ending 31st, December 1987.

Appropriation.

The sum specified in the preceding section shall be appropriated for the supply of the heads specified, and in the amounts respectively specified in relation thereto, in the Schedule to this Act.

Schedule.

- The total sums authorised by Contingencies Warrants issued by the Minister in exercise of his powers under section 15 of the Public Finance and Audit Act 1978 for the financial year 1987 shall not exceed the following amounts -
- (a) in respect of Heads of Recurrent Expenditure, five million dollars; and
- (b) in respect of Heads of Development Expenditure, five million dollars.
