

LOCAL GOVERNMENT (AMENDMENT) ACT 1988

(NO. 10 OF 1988)

Passed by the National Parliament this fifth day of April 1988.

AN ACT to amend the Local Government Act, in order to make provisions for the extention of the period of office of members, including that of the President and Vice President to four years.

ENACTED by the National Parliament of Solomon Islands.

Short title.

1. This Act may be cited as the Local Government (Amendment) Act 1988.

Amendment of section 11 of Cap. 14.

2. Subsection (1) of section 11 of the Local Government Act (hereinafter referred to as the principal Act) is hereby amended by deleting therefrom the word "three" and substituting therefor the word "four".

Amendment of section 15 of the principal Act.

- 3. Section 15 of the principal Act is hereby amended in the following respects -
 - (a) in subsection (2) by deleting the word "annually"; and
 - (b) by deleting from subsection (6) the words "normally be for one year" and substituting therefor the words "be for four years".

Transitional and Savings.

4. The persons holding office as elected members of a Council and every elected President and Vice President of a Council immediately before the commencement of this Act, shall continue to hold such office in accordance with the provisions of sections 11 and 15 of the principal Act as amended by this Act.
