

AN ACT to appropriate two hundred and forty-five thousand nine hundred and seventy-two dollars to the service of the year ending 31st December 1988.

ENACTED by the National Parliament of Solomon Islands.

Short title.

1. This Act may be cited as the 1988 Supplementary Approxiation (No. 3) Act 1989.

Authorisation of issue from the Consolidated Fund \$245,972 to the service of 1988.

2. The issue from the Consolidated Fund is hereby authorised of the sum of two hundred and forty-five thousand nine hundred and seventy-two dollars to be applied to the service of the year ending December 1988.

Appropriation.

Schedule.

3. The sum specified in the preceding section shall be appropriated for supply of the Heads specified, and in the amounts respectively specified in relation thereto, in the Schedule to this Act.
