

AN ACT to appropriate two million and two hundred sixty seven thousand dollars to the service of the year ending 31st December 1989.

ENACTED by the National Parliament of Solomon Islands.

Short title.

1. This Act may be cited as the 1989 Supplementary Approxiation Act (No. 3) 1989.

Authorisation of issue from the Consolidated Fund of \$2,267,000 for the service of 1989.

2. The issue from the Consolidated Fund is hereby authorised of the sum of two million and two hundred sixty seven thousand dollars to be applied to the service of the year ending 31st December 1989.

Appropriation.

Schedule.

3. The sum specified in the preceding section shall be appropriated for supply of the Heads specified and in the amounts respectively specified in relation thereto in the Schedule to this Act.
