

AN ACT to appropriate twenty million three hundred and seventyeight thousand two hundred and seven dollars fifty-three cents to the service of the year ending 31st December 1990.

ENACTED by the National Parliament of Solomon Islands.

Short title.

1. This Act may be cited as the 1990 Supplementary Appropriation Act (No. 2) 1990.

Authorisation of issue from the Consolidated Fund \$20,378,207.53 to the service of 1990.

2. The issue from the Consolidated Fund is hereby authorised of the sum of twenty million three hundred and seventy-eight thousand two hundred and seven dollars fifty-three cents to be applied to the service of the year ending December 31st 1990.

Appropriation.

3. The sum specified in the preceding section shall be appropriated for the supply of the heads specified and in the amounts respectively specified in relation thereto, in the Schedule to this Act.
