

THE 1990 **SUPPLEMENTARY APPROPRIATION ACT** (NO. 3) 1990

(NO. 12 OF 1990)

Passed by the National Parliament this twentieth day of November 1990.

AN ACT to appropriate four million seven hundred and ninetynine thousand two hundred and twenty-seven dollars ninety-eight cents to the service of the year ending 31st December 1990.

ENACTED by the National Parliament of Solomon Islands.

Short title.

1. This Act may be cited as the 1990 Supplementary Appropriation Act (No. 3) 1990.

Authorisation of issue from the Consolidated Fund \$4,799,227.98 to the service of 1990.

2. The issue from the Consolidated Fund is hereby authorised of the sum of four million seven hundred and ninety-nine thousand two hundred and twenty-seven dollars ninety-eight cents to be applied to the service of the year ending 31st December 1990.

Appropriation.

3. The sum specified in the preceding section shall be appropriated for the supply of the heads specified and in the amounts respectively specified in relation thereto, in the Schedule to this Act.
