AN ACT TO APPROPRIATE FOURTEEN MILLION THREE HUNDRED AND EIGHTY EIGHT THOUSAND AND EIGHT DOLLARS TO THE SERVICE OF THE YEAR ENDING 31ST DECEMBER 1990.

ENACTED by the National Parliament of Solomon Islands.

Appropriation.

1. This Act may be cited as the 1990 Supplementary Appropriation Act 1990.

2. The issue from the Consolidated Fund is hereby authorised of the sum of fourteen million three hundred and eighty eight thousand and eight dollars to be applied to the service of the year ending 31st December 1990.

3. The sum specified in the preceding section shall be appropriated for supply of the heads specified and in the amounts respectively specified in relation thereto, in the Schedule to this Act.
