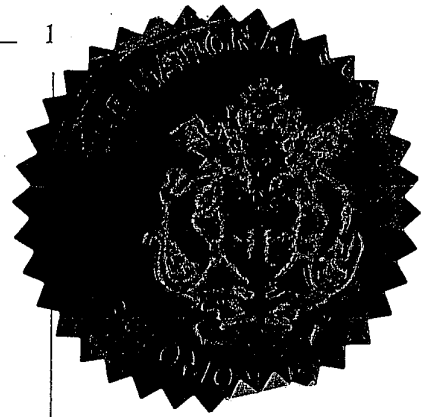

AN ACT TO Amend the Motor Vehicle (Third Party Insurance)
Act, 1972.

ENACTED by the National Parliament of Solomon Islands.

Short title and commencement.

1. This Act may be cited as the Motor Vehicle (Third Party Insurance) (Amendment) Act 1991, and shall come into operation on such date as the Minister may, by notice published in the Gazette, appoint.

Amendment of section 3 of Act No. 16 of 1972.

2. Paragraph (b) of section 3 of the Motor Vehicle (Third Party Insurance) Act 1972, is hereby amended by deleting the words "the Government" that appear therein.
