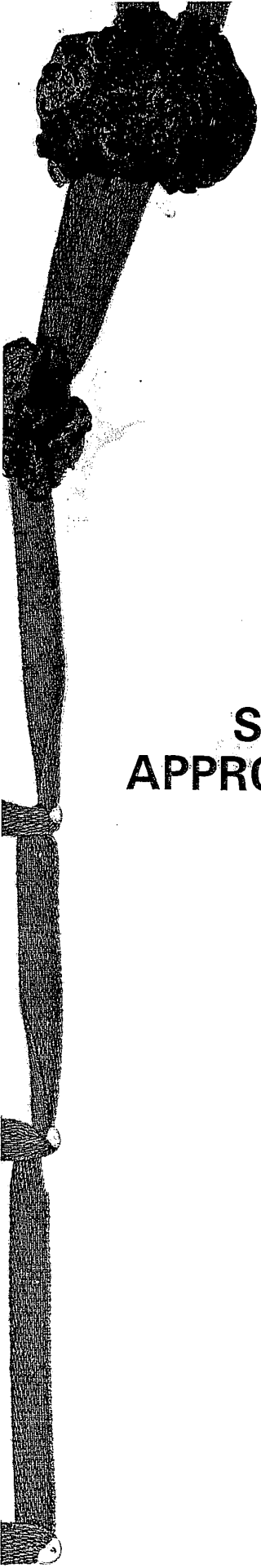

AN ACT To appropriate thirty eight million five hundred and seventy five thousand six hundred and fifty three dollars for the service of the year ending 31st December 1992.

ENACTED by the National Parliament of Solomon Islands.

Short title. 1. This Act may be cited as the 1992 Supplementary Appropriation Act, 1992.

2. The issue from the Consolidated Fund is hereby authorised of a sum of thirty-eight million, five hundred and seventy five thousand six hundred and fifty three dollars applied to the service of the year ending 31st December 1992.

Appropriate. 3. The sum specified in the preceding section shall be appropriated for the supply of the Heads specified, and in the amounts respectively specified in relation thereto, in the First Schedule.
