

#### FISHERIES (AMENDMENT) ACT 2009

Short title and commencement

1. This Act may be cited as the Fisheries (Amendment) Act 2009, and commences on the date it is published in the *Gazette*.

Principal Act amended 2. The principal Act is amended by amending the respective sections set out in column 1 of the Schedule by deleting the corresponding matters under column 2 and substituting the corresponding matters in column 3.
