

AN ACT TO VALIDATE ALL SUBSIDIARY LEGISLATION MADE AFTER THE COMMENCEMENT OF THE INTERPRETATION AND GENERAL PROVISIONS (VALIDATION AND INDEMNITY) ACT 2005.

INTERPRETATION AND GENERAL PROVISIONS (VALIDATION AND INDEMNITY) ACT 2009

Short title and commencement

1. This Act may be cited as the Interpretation and General Provisions (Validation and Indemnity) Act 2009, and commences on the date it is published in the Gazette.

Validation of subsidiary legislation

Cap. 85

- 2. This section validates any subsidiary legislation made between the commencement of the Interpretation and General Provisions (Validation and Indemnity) Act 2005 and this Act but is not published in the Gazette or laid in Parliament pursuant to section 61 or 62 of the Interpretation and General Provisions Act.
 - (2)For the purposes of subsection (1), any such subsidiary legislation is deemed to have been published in the Gazette or laid before Parliament, pursuant to this subsection.

3. For the purposes of section 2, any act done under such subsidiary legislation is validated, despite any non-compliance with section 61 or 62 of the Interpretation and General Provisions Act.
