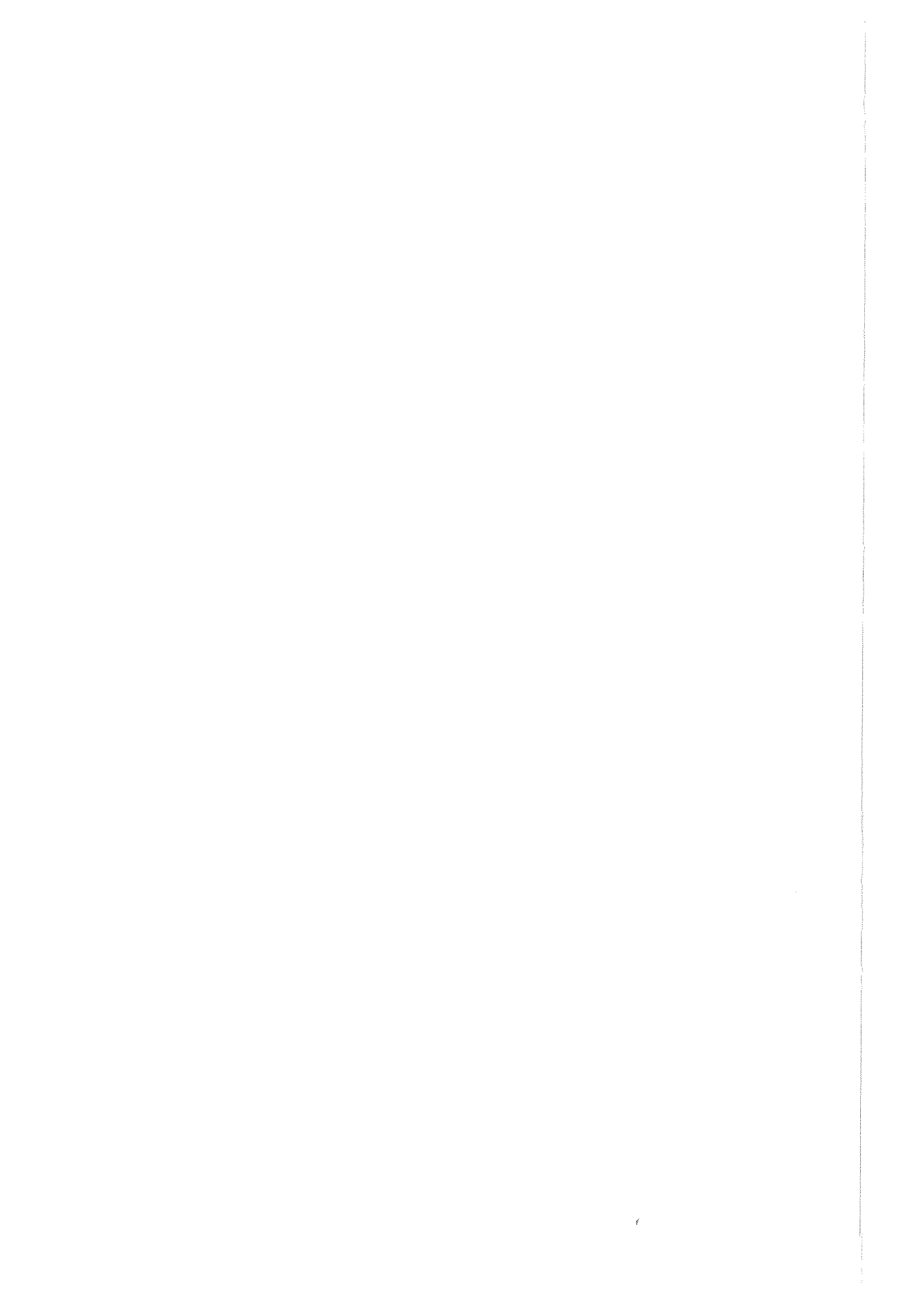

A

BILL

ENTITLED

**AN ACT TO APPROPRIATE EIGHTY MILLION SIX HUNDRED
SEVENTY EIGHT THOUSAND, FIVE HUNDRED AND THIRTY
THREE DOLLARS TO THE SERVICE OF THE YEAR ENDING
31ST DECEMBER 2001.**

ENACTED by the National Parliament of Solomon Islands.

Short title

1. This Act may be cited as the 2001 Supplementary Appropriation Act 2003.

Authorisation of issue from the Consolidated Fund
\$80,678,533 to the service of 2001

2. The issue from the Consolidated Fund is hereby authorised of the sum of eighty million six hundred seventy eight thousand five hundred and thirty three dollars to be applied to the service of the year ending 31st December 2001.

Appropriation

3. The sum specified in the preceding section shall be appropriated for the supply of the heads specified, and in the amounts respectively specified in relation thereto, in the Schedule to this Act.

THE 2001 SUPPLEMENTARY APPROPRIATION BILL 2003

Objects and Reasons

The object of this Bill is to authorise supplementary expenditure of eighty million six hundred seventy eight thousand five hundred and thirty three dollars incurred to the services of the Government under certain Heads of Expenditure for the year ending 31st December 2001 in addition the expenditures on those heads authorised by the 2001 Appropriation Act 2001. The Schedule contains the amount required to be authorised in each head and is supported by details set out in the Supplementary Estimates 2001.
