CONSTITUTION OF THE SOLOMON ISLANDS (SCHEDULE TO LN 43 OF 1978)

MEMBERS OF PARLIAMENT (ENTITLEMENTS) COMMISSIONREGULATIONS 1988

IN exercise of the powers conferred by section 69B (2)of the Constitution, the Members of Parliament (Entitlements) Commission makes the following regulations -

PART I - GENERAL

1. (1) These Regulations may be cited as the Members of Parliament (Entitlements) Commission Regulations.

Short Title

- (2) In any case where a duty is imposed on any public officer the obligation laid on such officer shall be read subject to General Orders, Financial Instructions and any other administration binding upon him.
- 2. These Regulations come into force on 1st April 1988.

Date of commence-ment

 These Regulations shall only be amended in accordance with the provisions of the Constitution.

Amendment to Regulation

4. The various terms used throughout these Regulations are as follows:

Definitions

"Chairman of the Parliamentary Caucus" means a Member of Parliament who is appointed by the Prime Minister to perform the following functions in addition to those added by the Prime Minister from time to time: attend cabinet meetings at the Prime Minister's request; alert the Prime Minister to any possible, significant delays in the implementation of matters agreed by the Cabinet; represent the Prime Minister on Committees of Cabinet as required, and perform the role of Government Whip when the House is in session.

"dependent children" includes children who are unmarried and wholly dependent and for whom the Member of Parliament has legal responsibility.

"child" includes any child for whom the Member has legal responsibility or has assumed social responsibility for medical treatment and education. "clerk" means the Clerk to Parliament.

"Leader of Official Opposition and of Independent Members" means the leaders for whose appointment provision is made in section 66(1) and (2) respectively of the Constitution.

"Member" means any Member of Parliament and in its general use the Prime Minister, the Deputy Prime Minister, Ministers and Leader of the Official Opposition and the Independent groups.

"Minister" means any member of Parliament.

"on duty" means when traveling to and from and participating in a meeting of Parliament or of a Special Select or Standing Committee or on occasions at which a Member is representing the Government of Solomon Islands.

"Prime Minister" means any Member of Parliament elected and appointed to that office under the Constitution.

"Parliament meetings" means the whole duration of sitting of Parliament including weekends and public holiday.

5. The Clerk shall maintain such accounting books and records of payments of salaries and allowance as an Accounting Officer of Government is required to keep under Government Financial Instructions

Accounting Books and Records

6. Any forms required specifically for the operation of these Regulations shall be designed, amended or deleted

Forms

from use by the Clerk in consultation with the Ministry of Finance

PART II – PAYMENTS

7. (1) The salary and allowances of a Member shall become payable upon the date of election under section 33 of the National Parliament (Electoral Provisions) Act (Cap. 87).

Salary and Allowances LN 21/2011 LN 27/2015

- (2) The salary and any allowance associated with the ministerial position of a Member shall cease to be payable upon the dissolution of Parliament or upon his vacating seat, whichever shall be earlier.
 - Provided that a caretaker Minister shall be entitled to claim his salary from the date of dissolution until the day prior to the formation of a new Government.
- (3) A Member sentenced by a court as specified in section 51(1) of the Constitution shall continue to be paid salary until –
- (a) the expiry of 30 days from the date the court delivers the sentence:
- (b) if appeal is pending, the expiry of any extension granted by the Speaker or approved by Parliament; or
- (c) the appeal is determined resulting in the Member's seat becoming vacant.
- 8. (1) The Clerk shall prepare salary authority forms in duplicate for submission to the Treasury. The reason for the application shall be stated and, where applicable, any relevant authority quoted. The receipt of the authority shall be acknowledged by returning the duplicate to the Clerk bearing the Member's file number.

Salary Authority

- (2) Salary authorities shall show details of basic salary, allowances of all types and deductions for income tax, rent or other purposes.
- (3) Salary authorities shall be submitted-
 - (a) on first election;
 - (b) when changes are made in monthly payments of allowances or deduction or the method of payment;
 - (c) to stop payment.
- 9. (1) Salaries may be paid in one of three ways:

Method of Payment

- (a) direct to a bank account on the request of a member submitted on the appropriate form of authority;
- (b) by cash or cheque to the Member directly;
- (c) to a third party; provided that the Member has given a signed authority in writing authorizing a specifically named person to collect the payment. Such authority shall clearly state how long it shall remain in force.
- (2) Constituency Allowance is for the purpose of a Member touring his Constituency at least thrice a year and is not to be paid as part of basic salary but to be drawn in three equal installments not being less than three months apart. The rate is as specified in Appendix A7.

(3) (a) Subject to the condition laid down in paragraph (b), members shall be paid a financial allocation Members Discretionary Fund within their constituencies.

Subsistence allowance

A Member (other than a Minister) shall be entitled to \$300 a day local subsistence allowance inclusive for weekends and public holidays when attending a Parliament meeting.

11A(1) A Person who has been a Member for a period of at least six months shall be entitled to a terminal grant as specified in Appendix A, at the end of the life of Parliament. The Terminal Grant shall be paid immediately upon the death or resignation of a Member as the case may be.

- If a Member resigns or ceases to be a Member during but is re-elected in the same life of Parliament, the Member is not entitled to be paid terminal grant unless the Member was paid partial terminal grant under sub-regulation (3), in which case shall be paid the difference if entitled to full terminal grant.; and
- The terminal grant or a proportion thereof of a deceased (2) Member shall be payable to the spouse and if there is no surviving spouse, then to the legal representative.
- A Member who has served for less than six months shall only be entitled to as many one-sixth of the full terminal grant for every full month of service.
- Any debt outstanding and owing to the Government shall be deducted from the terminal grant before any payments is made to a Member with the exception of those Members who have been medically certified to be wholly dependent and incapacitated.

A Member shall become a contributor to the National Provident Fund from the date he is duly declared elected by the Returning Officer and confirmed by the Speaker, provided the Minister of Finance and Treasury has made a declaration under section 2 of the National Provident Fund Act making Members employees of the Government for the purposes of that Act. Provided that no such declaration shall be made in respect of the Prime Minister.

- A Member who is already entitled to a life pension under regulations 11C(1) or 11D(2) as at 1st April 1990 shall not be a contributor to the National Provident Fund under paragraph (1) of this regulation.
- 11(C) A Member who had served in Parliament for an aggregate period of years specified in column 1 of the Table is entitled to a life pension at the per centum rate of the current annual basic salary of a Member as set out in column 2 of the Table below. This pension shall be paid fortnightly.

11.D.(1) With the exception of a recipient who is medically certified to be wholly dependent on care provided by another person and incapacitated, the pension's payable as per the table in 11C shall be frozen if a recipient re-enters Parliament or is serving as a Minister or Prime Minister following the dissolution of Parliament pending a National Election.

- (2) In calculating the number of years for pension entitlements under these Regulations, only parliamentary service commencing from 1970 and thereafter shall be taken into account.
- (3) Where a Member of Parliament had died, his pension scheme shall be transferred to his surviving legal spouse until the spouse remarries.

Pension of deceased Member to be transferred to surviving legal spouse

(4) In the circumstances that a member qualifies for pension both as a member or a Governor General, he or she is eligible to only one pension of his choice.

(5) The Commission may review these pension rates.

12. Any Member of Parliament duly approved to travel overseas on official trip including spouse is eligible to apply for Travel Insurance and Life Insurance with any reasonable Insurance firm in Honiara to be administered by the Clerk to Parliament.

Insurance Scheme

13. (1) Where a Member dies whilst being a Member of Parliament a sum of \$150,000 for death benefit including all benefits owing to the widow or widower under the Regulations, shall be paid to the widow or widower or to the legal personal representative of the deceased Member.

Where a Member sustains bodily injuries (not resulting in death) from an accident arising out of and in the course of his official duties, the Member shall be entitled to compensation for such bodily injuries in accordance with the Workmen's Compensation Act.

14. The Clerk shall ascertain that all debts to Government are settled by obtaining a certificate to that effect from all Ministries.

Debt

15. (1) The Prime Minister shall receive an annual hospitality allowance of an amount voted by Parliament.

Hospitality allowance LN 215/2004

(2) Ministers, the Leader of the Opposition or the Leader of Independent Group will obtain funds for official hospitality from a vote provided for the purpose and controlled by the Prime Minister.

Appointment Grant LN 215/2004 LN 27/2015

- 16. (1) A Member elected to Parliament shall receive an appointment grant at the rate prescribed in Appendix A2. Any Minister, Leader of the Opposition, Leader of the Independent Group, Deputy Speaker, Chairman of the Government Caucus and Chairman of the Standing Committees of the Parliament shall receive a further grant at the rate prescribed in Appendix A2 on his or her appointment.
 - (2) The appointment grant under sub-regulation (1) is payable only once during the life of Parliament.
 - (3) No additional appointment grant shall be paid if
 - (a) a Member resigns or ceases to be a Member and is again re-elected into the same life of Parliament;
 - (b) a Member resigns or is removed from an office in subregulation (1) and is re-appointment to that office or another office.
- 17 (1) A Member is entitled to a maximum \$10,000 education grant a year for the education of his or her children in schools within Solomon Islands. The education grant shall be paid directly to the member of Parliament.

Education Grant

PART III – TRAVELLING IMPRESTS

18. (1) An imprest is a sum of money issued to a Member to make payments directly for specified expenditure vote for which vouchers cannot be presented conveniently to a sub-accountant in the usual way.

Use of Imprest

- (2) An imprest may be granted to any Member of Parliament when touring locally or overseas on approved government business for travel and transport costs, accommodation and other incidental costs in accordance with Appendix A.
- Imprests are the personal responsibility of the Member in whose name they are issued. Imprest holders are not relieved of their responsibility until the imprest has been retired in full and found to be correct.
- 19. The Clerk shall be responsible for calculating the amount of any imprest and for ensuring that the necessary documents are provided to retire the imprest correctly.

Responsibility of Clerk

20. An imprest warrant shall be prepared on the appropriate form and shall be –

Imprest Warrant LN 36/90

- (a) authorized by the Secretary to the Prime Minister in respect of an imprest issued to a Minister;
- (b) authorized by the Clerk in respect of an imprest issued to other Members including the Leader of the Opposition, Leader of the Independent Group, Deputy Speaker, Chairman of the Government Caucus and Chairman of the Standing Committees of the Parliament.

LN 27/2015

21. A Member issued with an imprest shall submit no more than three days after returning to Honiara all reasonably available bills, receipts and other documentation required to support the expenditure incurred under the imprest together with any cash balance to the respective Authority under regulation 20.

Retirement of Imprest LN 36/90 22. The following items may be charged to a traveling imprest –

Charges Imprest LN 36/90

- (a) hotel bills for business class accommodation and food and standard service charge percentage on such items, including official communication charges, laundry and dry cleaning;
- (b) travel expenses such as airport charges, transport to and from airport or other duty journeys;
- (c) the cost of a chauffeur-driven hire car for Ministers when representing Solomon Islands at conferences where the host country does not provide transport; provided that such transport shall be used only on duty or for traveling to and from official functions connected with the visit;
- (d) any hospitality allowances provided under regulation55;
- (e) any non-accountable allowances approved under regulation 58.
- 23. Alcoholic beverages, soft drinks and cigarettes shall not be charged to a traveling imprest, except alcoholic beverages and soft drink charges incurred under regulation 55(3).

PART IV – ADVANCES AND LOANS

24. The Minister of Finance may authorize the issue of guarantees of loans to Members in the circumstances described in the following regulations. Application for such loans shall be made to the Clerk in the first instance, and in the case of Ministers should bear the recommendation of the Prime Minister.

Application

25. An advance of salary and allowances not exceeding one month's gross pay may be made by the Clerk in consultation with the Treasury -

Advances of Salary

- (a) in case of serious illness or unforeseen domestic calamity or other circumstances which the Member could not have foreseen and for which he could not have made prior provision or;
- (b) when the Member will be traveling at the time payment is due and will require funds to use during his travel period in which case the sum advanced shall be in the next amount payable after standard deduction for tax, rent, advances, or other purposes have been made.
- 26. (1) An advance of salary made in the circumstances described in paragraph (a) of regulation 25 shall be repaid over a period not exceeding three months starting when the advance is made.
 - (2) An advance of salary made in the circumstances described in paragraph (b) of regulation 25 shall be payable from the salary due for the month in which the advance is made.

Repayment

27. If funds are available, the Permanent Secretary, Ministry of Finance may issue a guarantee to a bank in support of a Member's application for a bank loan. The Member shall make the necessary arrangements with the bank and complete the application in Form TY84/1 set out in Appendix C. Each application for a loan shall be supported by a pro-forma invoice, receipted insurance cover note and works valuation certificate in case of a second-hand item, where necessary.

Guarantee of Loans

28. (1) The sum guaranteed by the Government shall not exceed \$100,000. The period of the guarantee shall exceed the prescribed life of the current Parliament and full

Limits and Purposes of Guarantees repayment must be made either before the dissolution of Parliament or, if the Member shall cease to hold office, on demand LN 36/90

(2) Where the official duties of the Prime Minister, a Minister, the Leader of the Opposition, Leader of the Independent Group, Deputy Speaker, Chairman of Government Caucus, Chairman of the Standing Committees of the Parliament or a Honiara Member obliges him to live in Honiara he is entitled to be given a Government guarantee, not exceeding \$200,000 to purchase his own house in Honiara. As a condition of the guarantee, the Government shall have the first charge over the house and such guarantee shall not expire on the dissolution of Parliament but shall remain in force while Government continues to hold the first charge.

LN 27/2015

Provided that no such Government guarantee shall be given to any person who, or whose spouse, owns a private house in Honiara.

29. On acceptance of the application by the Minister of Finance and after the completion of an agreement between the Member and the Government, the Permanent Secretary, Ministry of Finance, shall issue a recommendation to such bank as the Member may require recommending that the said bank may make the loan. It shall then be the responsibility of the Member to make all further arrangements with the bank and meet all such conditions as the bank may require.

Loan Agreement

When a member dies or vacates his seat in Parliament the amount outstanding on an advance or guaranteed loan may be recovered from any pay, terminal grants, pensions or ex-gratia payments for which the Member or his legal personal representative are eligible and any additional sum due shall be recoverable from any collateral or security held by the Member of his estate.

Abnormal repayment

31. In the event that any Member should decline to hand over any balance remaining to be paid to Government, the Clerk shall take the following actions:

Government Dues LN 27/2015

- (a) The Clerk shall issue a fourteen (14) days' notice to the Member reminding him of the government dues;
- (b) If there is no response from the Member after the fourteen (14) days' notice, the Clerk shall issue a further (14) days' notice and direct the Member to pay the dues within that 14 days and inform of the next course of action to be taken:
- (c) If a Member fails to comply with (b) above, the Clerk shall recover the Member's outstanding dues from his pension scheme in accordance with the Financial Instructions and Labour Act and shall inform the Accountant General, Treasury and Auditor General of such action.

PART V – ACCOMMODATION

32. The Prime Minister shall occupy (without payment of rent or tax on the private benefit thereof) the official residence of the Prime Minister and shall be provided with two drivers and such domestic staff as the Secretary to the Public Service of the Ministry of Public Service may consider reasonable together with full furnishings and equipment for the house and upkeep of such house shall be a charge on public funds.

Prime Minister

- 33. (1) A Member of Parliament is entitled to accommodation to a maximum cost of \$20,000 per month.
 - (2) A Member of Parliament is entitled to:

Accommodation of Members. LN 56/93 LN 59/2000 LN 215/2004 LN 27/2015 LN 14/2016

LN 195/2020 LN 55/2021

- A domestic employee, a gardener, and a driver at a rate of pay approved by the Permanent Secretary of the Ministry responsible for public services; and
- b) The supply of:
 - i) Water at a maximum rate of \$2,000 per month and
 - Four 45 kilogram bottles of gas per annum, and
 - iii) electricity at a maximum rate of \$8,000 per month; and
- c) The supply of:
 - i) Phone credits for a prepaid mobile phone at a maximum rate of \$3,000 per month except the Prime Minister who is entitled to a maximum rate of \$3,500 per month; and
 - ii) A telephone installed and maintained at the Members accommodation.

The costs of the following are to be paid out of public funds:

- a) employees employed under sub regulation
 (2)(a);
- b) supply of water, gas and electricity under sub regulation (2)(b);
- phone credits and telephone expenses under sub regulation (2)(c)."
- 35. While touring on Government business a Minister, the Leader of Opposition, Leader of the Independent Group, Deputy Speaker, Chairman of the Government Caucus, Chairman of the Standing Committees of the Parliament or a Member may either be accommodated at a hotel resthouse and his accommodation and all reasonable meals expenses will be paid for and a touring allowance of \$300.00 per day will be payable in addition.

36. All accounts for accommodation and meals will be sent to the Clerk for payment.

Accounting for Accommodation

37. Accommodation outside Honiara will be provided free of charge on the same terms and conditions as for touring on duty for Members traveling to or from meetings of Parliament or of Special Select or Standing Committees. Accommodation while traveling to or from meetings

38. Accommodation will be provided only for unavoidable stopovers where transport is not immediately available to complete the journey.

Accommodation during stopovers

39. In all cases the Provincial Secretary of the Province concerned will certify on the account that the charges were incurred because of unavoidable delays in transport.

Authority to certify other costs

PART VI - TRAVEL

40. Two official vehicles will be provided for the Prime Minister's use, with drivers and running costs being met from public funds.

Prime Minister

41. (1) The Prime Minister, Ministers, Leader of the Opposition, Leader of the Independent Group, the Deputy Speaker, Chairman of the Parliamentary Caucus and Chairman of the Standing Committees of the Parliament will be provided with Government funded trips for himself, his legal spouse and children as follows:

Independent Group,

(a) from his or her place of domicile or the central point of his or her Constituency to Honiara, on first appointment;

Deputy Speaker, Chairman of the Government Caucus and Chairman of the Standing Committees of the Parliament LN 30/95 LN 215/2004 LN 55/2006 LN 23/2010 LN 27/2015

(b) four return trips in each calendar year between Honiara and any place designated by him or her within the constituency or spouse's place of domicile, or any other place in Solomon Islands;

- (c) from Honiara to his or her place of domicile or the central point in his or her constituency, on relinquishing appointment.

- 51. A Member who is required to travel overseas on duty is eligible to receive a subsistence allowance as specified in Appendix A8.

Subsistence allowance

52. (1) Subsistence allowance is intended to cover, for a complete period of twenty-four hours, three meals a day, plus service charges, taxes, and incidental expenses at the place of accommodation, including official communication charges. Other incidental expenses such as taxis or airport taxes must be claimed separately.

- (2) Subsistence allowance is payable for a complete period of twenty-four hours only; provided that broken periods of twenty-four hours which include a night, or from midnight to 6:00 am may be claimed a full rate.

- (2) In such circumstances the Prime Minister will authorize a conference rate equal to a full hotel charge for accommodation, breakfast, service and taxes plus half the standard rate of subsistence allowance prescribed.
- (3) In these circumstances no further allowance for incidental expenses or hospitality will be paid.
- 55. (1) Where the Prime Minister considers that the Government may be under an obligation to provide or return hospitality at an overseas conference, he or she may authorize an allocation of funds to a Member for this purpose.

Refunds

57. (1) Where it is necessary to spend a period in transit and meals and accommodation are included with passage costs, no allowance is payable.

Allowances in transit

- (2) Where the period in transit includes an overnight stop and meals and accommodation are provided at the expense of the carrier an allowance of one-fifth of the standard rate for the place of stop-over will be payable to cover the incidental expenses.
- (3) Where a Member is detained overnight in transit and the charges for accommodation and meals are not provided at the expense of the carrier, he or she will be eligible to claim subsistence allowance at the rate applicable to the place in which he or she is detained.
- 58. A member is entitled to clothing allowance at the rate set out in Appendix A3 for the term of a life of Parliament payable when the electoral Commission publishes in the Gazette, under section 107(1)(b) of the Electoral Act 2018, the notice declaring the member to be the elected candidate; and

PART VII – MEDICAL ENTITLEMENTS

59. **Definitions**

In this Part:

"Committee of the specialists of the Ministry" means a committee of specialists employed by the Ministry who are responsible for recommending that persons requiring essential medical treatment that is not available in Solomon Islands be referred to hospitals or other medical facilities overseas";

Medical Entitlements LN 195/2020

- "Committee of specialists of the agent" means the committee of specialists engaged by a health and medical agent to assess an entitled person's medical condition and their need for medical treatment;
- "Contribution" means the amount of money payable to a health and medical treatment:
- "Entitled person" means a Member, the Member's legal spouse, or a dependent child of the Member;
- "Essential medical treatment" means medical treatment which, if not administered, would result in a medical emergency or death;
- "Health and medical agent" means an insurer or other person with whom a health and medical arrangement is made under regulation 61;
- "Health and medical arrangement" means an arrangement in writing to cover the costs of health and medical services provided to entitled persons in accordance with the arrangement in return for the payment of a contribution;

"Health and medical services":

- (a) means:
- (i) examination, care, medication or other treatment, surgery or other procedure for the purpose of diagnosing or treating a health problem or disorder or giving remedial care during treatment; or
- (ii) provision of information about health and a healthy lifestyle or the care and management of specific medical conditions; and
- (b) does not include services excluded by the health and medical arrangement;

"Legal spouse", of a member, means:

- (a) the person to whom the Member is married in accordance with the Births, Marriages and Deaths Act (Cap. 169); or
- (b) the person to whom the Member is married in accordance with the Islanders' Marriage Act (Cap.171) and their marriage has been registered under that Act;
- "Ministry" means the Ministry responsible for health and medical services;
- "Specialist" has the same meaning of "Specialist" under section 2 of the Medical and Dental Practitioners Act (Cap.102).

60. Entitlement to receive medical services

An entitled person is entitled to the following:

- (a) health and medical services from the National referral Hospital or any other government medical facility in Solomon Islands;
- (b) payment of the contribution to cover the costs of health and medical services provided to the

- entitled person under a health and medical services arrangement;
- (c) payment of the amount by which the sum of the following costs exceeds the value of one quarter of the Member's monthly salary;
 - any health and medical services received by the entitled person overseas on the referral under regulation 62 of the committee of specialists of the Ministry that are not covered by a health and medical arrangement;
 - payment of the cost of travel for receiving health and medical services of the entitled person referred to in subparagraph (i) that is not covered by the health and medical arrangement;
- (d) reimbursement of the costs of health and medical services provided to the entitled person in Solomon Islands by a private medical practitioner or private health clinic or other facility that are not covered by a health and medical arrangement.

61. Commission may enter health and medical arrangement

- (1) The Commission may enter into an arrangement with a health and medical agent under which the agent covers the costs of health and medical services provided to entitled persons under the arrangement in return for the payment of a contribution.
- (2) The arrangement may include provision for the payment of the costs of:
 - (a) travel for receiving health and medical services; and
 - (b) accommodation while receiving health and medical services.

62. Manner in which referrals are made

Referral of an entitled person to receive health and medical services overseas is made by the committee of specialists of the Ministry on the grounds that:

- a) it is essential for the restoration or maintenance of the entitled person's health;
 and
- b) the entitled person's health problem or disorder is treatable; and
- c) the expertise, equipment or treatment required are not available in Solomon Islands; and
- d) the medical services are of the highest quality and at the most competitive cost.

Medical treatment outside Solomon Islands LN 195/20

63. Medical emergencies overseas

(1) The entitlement under this regulation is in addition to the entitlement under regulation 60.

Other charges outside Solomon Islands 195/20

- (2) A member who is on travel duty outside of Solomon Islands is entitled to the cost of essential medical services and cost of accommodation while receiving the essential medical services if:
 - (a) the member becomes critically ill or requires urgent medical attention; and
 - (b) the cost of essential medical services and cost of accommodation are not covered by the
- 3) A member who is on travel duty outside of Solomon Islands at the invitation of another country or a multilateral, international or regional organization is entitled to the cost of essential medical services and cost of accommodation while receiving the essential medical services not met by that country or organization if:
 - (a) the member becomes critically ill or requires urgent medical attention; and

Recoverable Charges 195/20 (b) the cost of essential medical services and cost of accommodation are not covered by the health and medical arrangement."

PART IX - MISCELLANEOUS

67. Members required to tour outside Honiara as Members of Special Select or Standing Committees appointed under Order 68 of the Standing Orders of the National Parliament shall receive touring allowance in accordance with Regulation 35. All costs associated with attendance at the said committee meetings shall be met from the Parliament Head of the estimates – Members of such committees during sittings shall be paid a sitting allowance at the rates as appear in Appendix A10.
