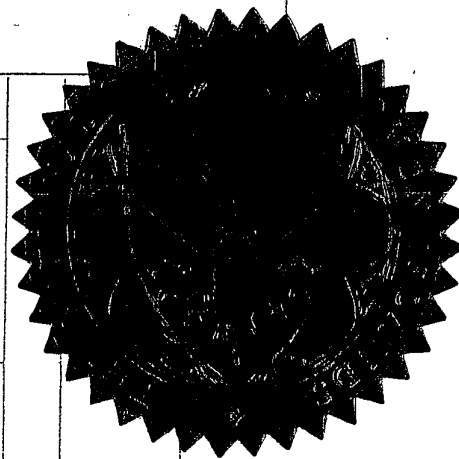



AN ACT to amend the Census Act, Cap. 29.

ENACTED by the National Parliament of Solomon Islands.

4  
Short title.

1. This Act may be cited as the Census (Amendment) Act 1987.

Addition of section 7A to Cap.29.

2. The Census Act (hereinafter referred to as the "principal Act") is amended by adding immediately below section 7 the following:-

"Delivery of returns to Government Statistician. No. 6 of 1970. 7A. (1) As soon as reasonably practicable after making such reports of the census and abstracts of the returns under section 7, the Commissioner shall deliver such abstracts and any other documents comprised in the returns to the Government Statistician appointed under the Statistics Act 1970.

(2) Sections 6, 7 and 13 of the Statistics Act 1970 shall apply in relation to any abstract, document or information comprising or contained in any returns delivered to the Government Statistician pursuant to subsection (1)."

Amendment of section 8.

3. Section 8 of the principal Act is amended:-

- (a) in subsection (1), by substituting for the expression "twenty dollars" the expression "six hundred dollars"; and
- (b) in subsection (2), by substituting for the expression "one hundred dollars" the expression "one thousand two hundred dollars".
