AN ACT to appropriate twenty-nine million fifty-three thousand four hundred and eighty-three dollars for the service of the year ending 31st December 1993.

ENACTED by the National Parliament of Solomon Islands.

Short title.

1. This Act may be cited as the 1993 Supplementary Appropriation Act 1993.

Authorisation of issue from the Consolidated Fund of \$29,053,483 to the service of 1993. 2. The issue from the Consolidated Fund is hereby authorised of a sum of twenty-nine million fifty-three thousand four hundred and eighty-three dollars to be applied to the service of the year ending the 31st December 1993.

Appropriation.

3. The sum specified in the preceding section shall be appropriated for the supply of the Heads specified, and in the amounts respectively specified in relation thereto, in the First Schedule.
