AN ACT To Amend the Investment Corporation of Solomon Islands Act.

Short title.

1. This Act may be cited as the Investment Corporation of Solomon Islands (Amendment) Act 1995.

Amendment
of section 15
of Act No. 6
of 1988.

2. Subsection (1) of section 15 of the Investment Corporation of Solomon Islands Act is hereby amended as follows -

- (a) by deleting the comma that appears after the words "from any financial year" and substituting therefor a fullstop; and
- (b) by deleting all the words that appear after the fullstop so substituted.
